### **LEGAL NOTICE**

## 1. WHO ARE WE?

### 2. PURPOSE

By accessing and using the Platform, you acquire the status of "User," which implies full acceptance of all the provisions in this Legal Notice and the other "Legal Texts," including this Legal Notice, the Privacy Policy, the Terms of Use, and the Cookie Policy.

This Legal Notice governs access, navigation, and use of this Website, without prejudice to INFORM's right to modify its presentation, configuration, and content, as well as the conditions required for its access and/or use. Access and use of the Platform's content after such modifications come into effect implies acceptance of them.

### 3. USE OF THE PLATFORM

## 4. PRIVACY

All data provided to INFORM through the Platform will be processed by INFORM as Data Controller, respecting the confidentiality, integrity, and availability of personal data in accordance with the <a href="Privacy Policy">Privacy Policy</a>.

### 5. COOKIES

The use of cookies on the Platform will be governed by the Cookie Policy.

# 6. COMMERCIAL COMMUNICATIONS

As long as the User provides their express consent, or in case of an existing contract with the User, INFORM will send commercial communications to keep them updated on all news and relevant information about INFORM or its services.

INFORM will continue sending these commercial communications while the User maintains their consent or while the contractual relationship remains in force. However, if the User no longer wishes to receive commercial communications, they may withdraw their consent through the form provided in such communications or by sending an email to <a href="mailto:privacy@inform.es">privacy@inform.es</a>.

#### 7. LINKS

Likewise, the owner of any website wishing to insert a link to the Platform must first obtain authorization from INFORM.

INFORM shall not be responsible for the contents of those websites linked from the Platform and shall remain uninvolved in any relationships that may be established between their owners and the Users of the Platform.

## 8. INDUSTRIAL AND INTELLECTUAL PROPERTY

The intellectual and industrial property rights on the Platform, its graphic design, software code, trademarks, signs, text, images, and videos (hereinafter the "Content") are the property of INFORM.
